

Just a question. Is there a legal reason we are using the word “contest” and not “sweepstakes” or drawing?

Official Rules & Regulations

No purchase necessary. One valid entry per contestant, per day.

Beginning at 8:00 AM on September 9, 2020 and ending at midnight on October 11, 2020, you may enter the 225 contests once per day by completing and submitting the online app entry form.

You must be 21 years of age or older at time of entry to be eligible for this contest. This contest is void where prohibited by law.

On each of the first seven (7) days, a contest will be held for a \$100 gift card from a local restaurant in the 225 area code. Each winner drawn may select their favorite restaurant. You may enter once per day for each contest beginning September 9, 2020. A winner will be drawn the following day.

All those who enter will also be entered into a grand prize contest, which will continue until midnight on October 11, 2020. You may continue to enter once daily for the grand prize after the week of gift card drawings ends.
